Important notes before installing:

- All installation work should be done by a qualified professional to avoid damage to this product.
- This product is supplied raw and may discolour if exposed to direct sunlight for long periods. To avoid this, SAAS recommends colour matching this product to suit your vehicles interior. (See below for painting tips)

Fitting Steps:

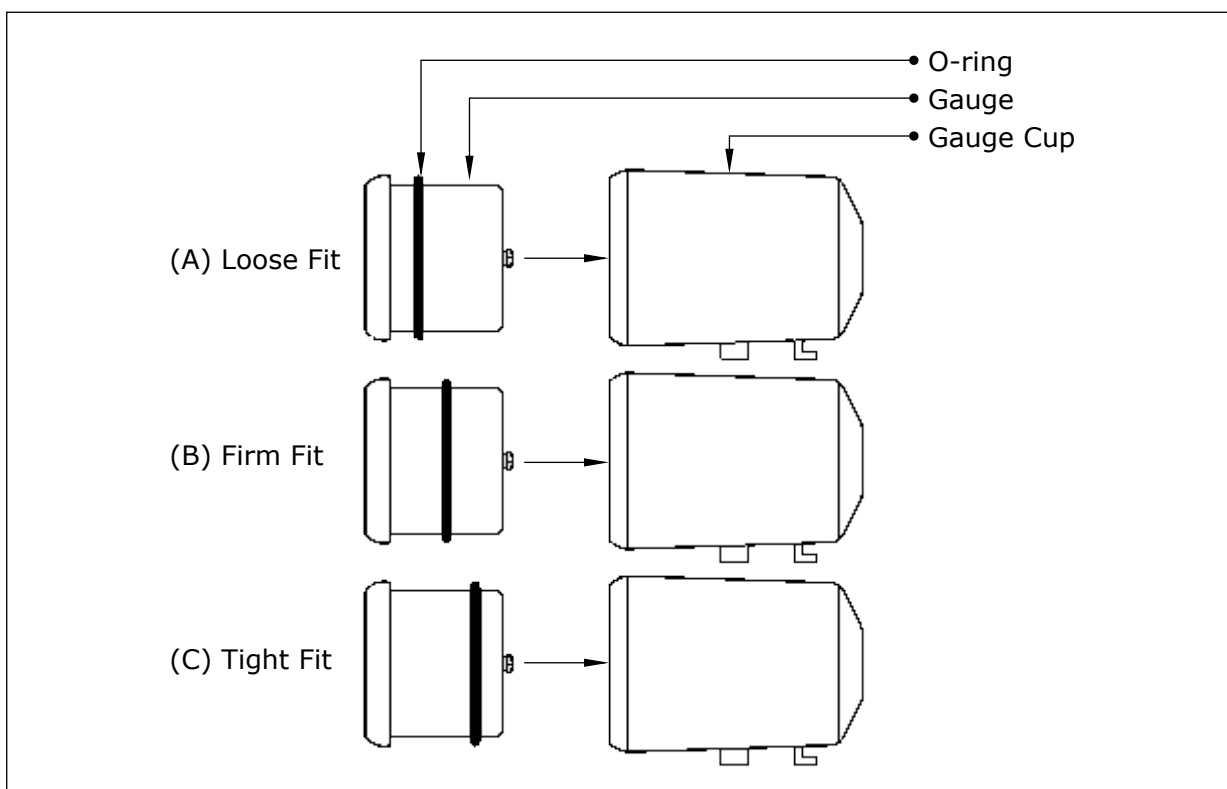
- Remove factory grab handle if fitted.
- Drill a 5mm hole, 30mm from the top and base of the pillar pod for the mounting rivets. (See page 2 for example)
- Using a marker, fit the pillar pod to the vehicle making sure it's in the correct location and mark the 2 holes to be drilled. Remove the pillar pod and drill 2 x 5mm holes into the vehicle's A-pillar. Clean the holes and use some anti-rust or paint to protect the metal surface.
- Fit the gauge cups to the pillar pod. (See page 2 for cup assembly)
- Fit the pillar pod to the vehicle using the supplied rivet clips.
- **Fitting Tip:** Do not insert the rivet clips all the way until your gauge installation is complete.

Painting Tips:

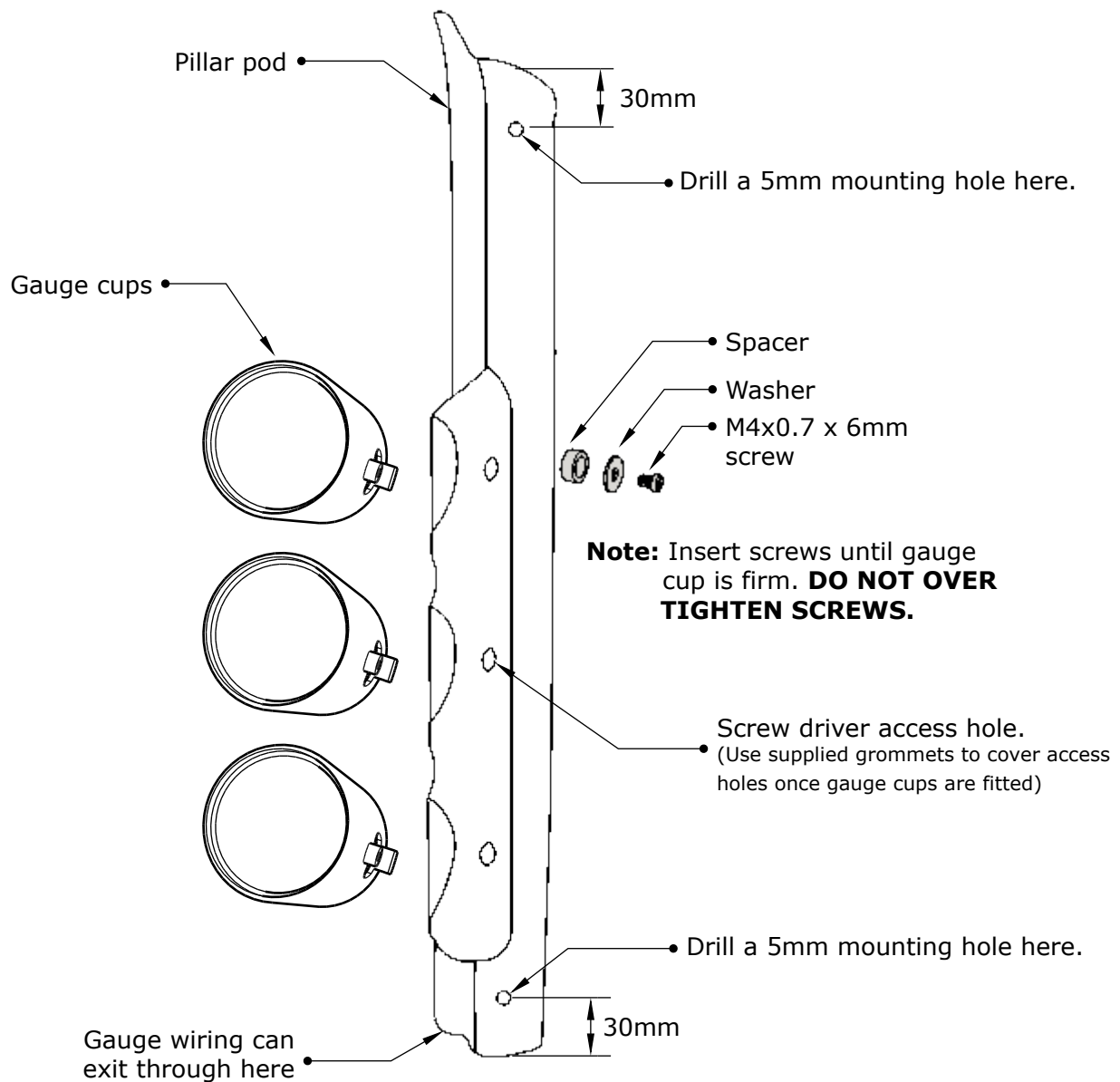
- **Colour Matching steps:** Use a scotch pad to lightly scuff the surface > clean with wax and grease remover > undercoat with plastic primer > spray top colour > do not clear coat.

Installing Gauges to Cups:

- The supplied o-rings (one for each gauge) are used to fit gauges to cups. The placement of the o-ring will determine how tight the gauge will sit in the cup. (refer to diagram)
